



Cruisin' Home Denton County Adoption Day 2011 Anchored to the Hearts of Denton Forever

The month of February is undeniably marked by love. However, it is incomparable to the mark of love the 4th Annual Denton County Adoption Day left on the hearts of the 19 families who adopted 31 children on November 4, 2011.

One defining uniqueness of the Denton County Bar Association is the spirit of generosity and giving back to the community. Returning to Texas from California, it is rare to witness a group of lawyers who care LESS about themselves and more about OTHERS. It is very evident that Adoption Day is a project that is embraced by members of our bar.

If you are new to the scene, Denton County Adoption Day is part of the nationwide effort to celebrate families who are welcoming new members from foster care and to draw attention to the continuing need for foster and adoptive homes.

This event is the result of a partnership between the Denton County Bar Association, Texas Department of Family and Protective Services, Court Appointed Special Advocates (CASA), and Denton County judges. Numerous donors and volunteers are also instrumental in making this event a success.

On the afternoon of November 3, 2011 the second floor of our modern

bustling County Courts Building and jury assembly room was transformed into the ultimate Cruizone: Adoption Day 2011. Each courtroom was softened with hundreds of teddy bears donated for the occasion, a themed Cruise Ship designed and built with love by Michelle Houston's father and brother was assembled, and the stage was set for the passport tour. More than 200 volunteers swarmed in to transform the second floor of the Denton County Courts Building so that these new families would have a joyous embarkation into their new lives. For many of these children, this would be their first positive experience with the legal system.

New to the Adoption Day experience, family law attorney Collette Solis echoed sentiments felt by many involved; "When I walked into the jury room and saw all the festivities, I was overwhelmed with the feeling that we were all taking

On the morning of November 4th, each adoption family was assigned a “cruise director” to guide them to their passport destinations to ensure they didn’t miss a single opportunity in this fun-filled day. The first and most important passport destination was the adoption proceeding. Adhering to the formal proceedings, the presiding Judges also added their own personal touch. The heartfelt judicial proceedings were conducted by Judges Carmen Rivera-Worley, Bruce McFarling, Steve Burgess, L. Dee Shipman, Doug Robison, Margaret Barnes, and Jonathan Bailey. With a wave of their gavels and signing of the Orders, the Judges gregariously shared in the joy of the union of the families and each child left the courtroom with a teddy bear of their choosing. At the conclusion of their respective dockets, the Judges joined the families to enjoy the Cruizone festivities.

Education Opportunities for Paralegals

The Denton County Paralegal Association's (DCPA) annual membership drive is underway. Dues are just \$25.00 a year and offer many benefits for paralegals and legal assistants in Denton County. All members receive free accredited CLE at monthly meetings held at Oakmont Country Club. Speakers include local attorneys on a variety of areas of law. Other benefits of membership include a monthly newsletter, membership mixers, and the opportunity to get acquainted with other paralegals. DCPA provides pro bono service opportunities, including DCBA's Texas Lawyers for Texas Veterans legal clinics and Wills for Heroes project. Community Service is also important to DCPA, with members raising money for the Children's Advocacy Center of Denton County

and Denton County Friends of the Family.

There are a variety of membership levels available, including sustaining membership for businesses and law firms interested in supporting DCPA's goal of paralegal education. Information about DCPA, including membership applications and a directory of active members, is at www.dentonparalegals.org.

Local paralegals also benefit from membership in the Paralegal Division of the State Bar of Texas (PD). The PD functions as a section of the State Bar, offering discounts on State Bar CLE, as well as seminars exclusively for paralegals. PD members also have access to an email listserv of paralegals throughout Texas—always helpful for referrals or information about other areas of the state.

Members may register for a mentor/protégé program that offers another resource of information for paralegals with less than two years experience. Subscriptions to the Texas Paralegal Journal and the Texas Bar Journal are included. For more information about the PD, including membership levels, visit www.txpd.org.

Other opportunities for Texas paralegals include associate membership in the State Bar College, the Pro Bono College, and various State Bar sections, including the Family Law Section. The Texas Board of Legal Specialization offers certification for paralegals in family, criminal, real estate, civil trial, estate planning/probate, and personal injury trial law. The Texas Legal Services Center Seeks Attorney Assistance For Reduced Fee Lawyer Referral Service

Texas Legal Service Center (TLSC) is a nonprofit organization that offers free legal advice and limited services via a phone hotline to low income clients throughout the state of Texas. “While 70% of client calls can be resolved via our free hotline service, TLSC also offers clients a Lawyer Referral Service to fill the gap in services. When a referral is needed, hotline attorneys refer the client based on legal issue and geographic

location,” explained Moriah Steinthal, TLSC Title.

TLSC is currently recruiting attorneys who would be interested in taking referred cases from our legal hotline, and is accepting attorneys from all practice areas. There is no membership fee associated with the program, but a minimum malpractice coverage is required. Panel attorneys are not obligated to take any case that is referred. By working with TLSC’s

Lawyer Referral Service, attorneys are paid a reduced fee by the client, and they can also get credit toward their State Bar pro bono requirements. Additionally, a great service is provided to those of modest means.
